**ACCIDENT \*NEW CARRIER** Do you have kids playing sports, are you a weekend warrior, or maybe accident prone? Accident plans are designed to help pay for medical costs associated with accidents and benefits are paid directly to you.

**CANCER \*NEW CARRIER** Cancer insurance offers you and your family supplemental insurance protection in the event you or a covered family member is diagnosed with cancer. It pays a benefit directly to you to help with expenses associated with cancer treatment.

TELEHEALTH\*NEW CARRIER With telehealth, you can get the treatment you need for minor sicknesses without having to visit your doctor's office. You'll gain access to medical consultations through phone call, email, and video chat. Telehealth will typically have you talking to a doctor within 30 minutes of setting up the appointment.

#### FLEX SPENDING ACCOUNT \*NEW ADMINISTRATOR Flex

spending account administration is moving to Higginbotham effective 9/1/2024. If you wish to make changes for the 2024-2025 plan year, you must log into **THE**benefits**HUB**. The contribution limit for 2024-2025 is \$3,200.

**HEALTH SAVINGS ACCOUNT:** If you wish to make changes for the 2024-2025 plan year, you must log into **THE**benefits**HUB**. The contribution limits for 2024-2025 are \$4,150 individual and \$8,300 family. If you're over 55+ you have an additional \$1,000

#### **FAQS**

#### CAN YOU HAVE BOTH AN HSA AND FSA?

No, you can only choose to enroll in one or the other, you cannot contribute to both HSA and FSA.

# WHAT IF YOU ARE CURRENTLY ENROLLED IN FSA AND WANT TO SWITCH TO HSA ON 9/1/2024?

If you are currently enrolled in a FSA and will be switching to HSA, be sure to exhaust all of your FSA funds by 8/31/2024.

# CAN YOU AND YOUR SPOUSE BOTH HAVE H.S.A AND F.S.A?

Please note that, in general, under IRS regulations, married couples cannot enroll in both a Flexible Spending Account (FSA) and a Health Savings Account (HSA). If your spouse is covered by an FSA that reimburses medical expenses, then you and your spouse are not eligible for the HSA, even if you would not use your spouse's FSA to reimburse your expenses. However, there are some exceptions to the general limitation regarding specific types of FSAs. For more information on whether you can enroll in a specific type of FSA or HSA as a married couple, contact the FSA and/ or HSA provider before enrolling or contact your tax advisor for further guidance.
