During the pandemic, schools were able to offer no cost meals to all students due to temporary program flexibilities provided by the federal government. These flexibilities have expired, and the U.S. Congress did not provide funding in this year's budget to allow schools to serve free meals to all students in the 2022-2023 school year.

The Child Nutrition Department of Sulphur Springs ISD will be processing Free and Reduced Meal Applications online for the **SULPHUR SPRINGS HIGH SCHOOL**. Entering the application in MEAL APP NOW eliminates lost forms and provides the district immediate access to your completed application for processing in minutes instead of the ten days that may be required for paper applications.
