Dear Parent or Guardian:

We are pleased to inform you that Sulphur Springs Independent School District will be implementing a program available to schools participating in the National School Lunch Program and School Breakfast Programs called the Community Eligibility Provision (CEP).

What does this mean for you and your children attending the schools identified below?

Great news! All enrolled students of Sulphur Springs ISD, Head Start through 12th grade, are eligible to receive a healthy reimbursable breakfast and lunch at no cost to your household each day of the school year. Your children will be able to participate in this meal program without having to pay a fee or submit a meal application.
